- Catholic Charities Disabilities Services: Rowena Smith, MSCJ, Associate Executive Director – Located in Albany, NY. Catholic Charities Disabilities Services, a not-for-profit agency of Catholic Charities of the Diocese of Albany, provides service coordination, HCBS services, family support services, environmental modifications, and self-directed supports to individuals with intellectual and developmental disabilities and traumatic brain injury.
