A REGIONAL PLANNING CONSORTIUM OVERVIEW:

As each region will experience unique challenges and opportunities as the behavioral health transition to managed care occurs, they will require in person dialogue and collaboration to resolve.

A <u>Regional Planning</u> Consortium (RPC) is a

regional board populated with community-based providers, peers/family/youth, county mental health directors, regional healthcare entities and managed care companies from each region.

The Purpose of the RPC is

to work closely with State agencies to guide behavioral health policy in the region, problem solve regional service delivery challenges, and recommend priorities for reinvestment of Medicaid savings.

WHAT ARE VALUE BASED PAYMENTS?

"Value-based programs reward health care providers with incentive payments for the quality of care they give to people with Medicare. These programs are part of our larger quality strategy to reform how health care is delivered and paid for. Value-based programs also support our three-part aim: better care for individuals, better health for populations, and lower cost"

WHO ARE THE BHCC LEADS?

"The New York State Office of Mental Health (OMH) and the Office of Alcoholism and Substance Abuse Services (OASAS) jointly announce awards for the NYS Behavioral Health Value Based Payment (BH VBP) Readiness Program. The funds have been awarded to selected networks of behavioral healthcare providers, called Behavioral Health Care Collaboratives (BHCCs).

The BHCCs will use the awards to help prepare behavioral health providers to engage in Value Based Payment arrangements, a financial incentive framework that rewards healthcare providers for improved quality, outcomes, and costs. A main goal is to improve the integration of physical and behavioral health."

WHO ARE THE BHCC LEADS IN CNY?

There are three BHCC Leads that cover the 6 county region. These providers are; Helio Health, The Neighborhood Center, and Family Counseling Services of Cortland County. BHCC UPDATES:

- o Helio Health: "The CNY BHCC has been focusing on finalizing our organizational structure in forming an IPA. The partners are close to completion of that task and will engage network partners in the implementation process as we move forward. Our sub-committees (quality, data and clinical) have been meeting bi-weekly to achieve their strategic goals including creating information sharing agreements, identifying initial measures, developing processes of how we will engage partners in the process of tracking and assessing data we currently have access to and looking at various platforms that could be beneficial in the future. The BHCC has been working on a website which will seek to ensure up to date information and news for all partners in the BHCC. We continue to work with other BHCCs, MCOs and state partners to successfully move toward our goal of value based contracting"
- o **The Neighborhood Center:** "We are in the process of selecting our Board of Directors. We hope to have that complete by the end of the month"
- o Family Counseling Services of Cortland County: "We're nearly ready to launch our use of the CCSI data platform across our network. We've selected five indicators that we will be tracking through the platform, which is based on PSYCKES data. We will use the CCSI platform as an interim solution until we select a full platform for long-term use. The McSilver Institute at NYU is completing an assessment of our network, including site visits at a number of agencies. We expect their report and recommendations in March. The PPSs have provided substantial information to further help us assess the network. Our HIT Committee is working with consultants from HMA to finish the RFP for a data-sharing platform that will be more comprehensive in meeting the needs of the Network. We expect to issue the RFP in April and ideally select the winning proposal by June or July. We're working on our BHCC website design and hope to launch that soon. Our legal consultants continue to move us forward with formation of our IPA. We're exploring options for a pilot VBP project with a smaller MCO. We remain engaged with the coalition of BHCCs across the state who are working on several issues around state-wide (shared) BHCC quality indicators and the BHCC universal consent form."

OMH TRAININGS:
