Biannual Chairs Meeting

Recap of Issues and Informed Dialogue Jacqueline Miller Jacqui let the board know that the RPC Co-Chairs Meeting occurred on 11/30/18.

i. Informed Dialogue: Transport to Pharm Jacqueline Miller

Jacqui provided an overview of the Mohawk Valley Transportation Issues that was presented at 11/30/18 RPC Chairs Meeting (see attached Informed Dialogue document). Sandra and Sue provided additional commentary and feedback on the dialogue with the State Partners around this issue. Issue was well received, and there is an opportunity to continue this dialogue.

ii. Issue: Physician Assistants

Susan Matt

Issues brought up by Finger Lakes Region. See PPT Slide for additional detail around this issue.

State Response- There is Waiver that exist- 19 have been approved. OMH agreed to take a look back at these issues- Are there creative solution to be able to utilize PAs in Article 31 clinics.

Sue asked-Do they use PAs in state operations? Joe believes they do, but is not 100% sure

There is an opportunity to continue to have an ongoing dialogue

Sandra had a question around Scope of practice? Only NY SED can give a waiver regarding scope of practice-

Joe- The waiver through OMH- Allows PA to practice, relaxes the OMH regs.

Jennifer Earl- When a provider submits this Waiver it is related to the 599.9 Staffing https://omh.ny.gov/omhweb/policy and regulations/adoption/part 599 2012022 7.html

Next Steps- Question-How are PAs utilized in the state psych system?

iii. Issue: Transportation to Open Access Sandra Soroka Sandra reviewed the state response regarding this issue (See PPT slide for additional detail). A list of the Open Access centers will be sent to DOH/MAS. There will be ongoing dialogue with the State Partners around this issue. The State is concerned around Fraud, and Medicaid imploding in on its self.

Montgomery County/Sara- Has a transportation coalition- They are looking at looking at creative solutions to getting people around town- up the hill (Ex: a Bus that costs 1 dollar).

Desiree- Her agency is also looking at creative way to utilizing funds to focus on transportation

Joe Simko, OMH-Encouraged MCOs to being these conversations back to their pharmacies to look at creative solutions-

Sue- OMH is looking to have further conversations with MCOs-Are there opportunities to see where else in the medical field it is working well and can we replicate this?

Sheila- CDPHP- Where it is working well, it may be agencies that are serving one facility, etc

iv. Informed Dialogue: Housing Susan Matt

See PPT slide for additional info on this topic. Mechanism to develop housing is very complex, there are multiple hoops. OMH is looking to train developers and providers on how to work these hoops.

ILS- This is an option to work with MCOs- Providers Apply to spend your premiums in a new way.

Sheila, CDPHP- MCOs are also looking at accessing funding through community partnerships – CDPHP has three housing initiatives in the works- may be a more efficient- CDPHP is partnering with community partners, provide money to address SDH needs.

Amy, Fidelis- MCOs are often donating money to various charities.

Sheila, CDPHP- Approved ILS applications are posted on the website

<u>VBP</u> Educational opportunities- In the NYC RPC region they brought together the MCOs, PPS, and BHCCs to take a look at what are the opportunities there are to collaborate. Will follow up with MCTAC to discuss further about this opportunity.
