Objective #1: St. Regis Mohawk Tribe Mental Health and SUD Services has initiated a prevention plan through their Zero Suicide Initiative to include community training with QPR and Mental Health Frist Aid. There have been 4 QPR trainings, two adult MH First Aid trainings and Two Youth MH First Aid Trainings provided to the community since March of 2024. This has been in partnership with their Zero Suicide Initiative, grant coordinator, mental health clinicians, CASAC counselors, Child and Youth Clinic Coordinator and Traditional medicine worker.

Objective 1: St. Joseph's secured funding for a multi-year funding agreement to provide Outreach and Engagement services. The funding expires in September of 2025. This has increased the agency's ability to provide outreach services including peers and transportation and engagement services including in-person and virtual services in the clinic and in-community. Citizen Advocates have targeted case managers provide engageclients via Motivational Interviewing. The 589/Crisis Residences, know as the Behavioral Health Urgent Care operated by Citizen Advocates provides an expanded level of care for youth and adults therefore increasing linkages to care.

Objective 1: Peer services are offered through St. Joseph's when available and will continue to explore an MOU with Community Connections to increase services provision within the correctional facility. St. Joseph's is currently providing transitional case management that includes referral and linkages to Community Connections and other local services. St. Joe's certified peers are also available to support individuals transitioning after release.

Objective 3: St. Joseph's was awarded the COTP RFA in 2023. The agency is working towards operationalizing the COTP in the Saranac Lake outpatient clinic. Once the COTP is operational, it is the intent of St. Joseph's to investigate the possibility of providing mobile OUD services in order to increase access to services.

• Franklin County has an unemployment rate of 6.6%, and 49.7% of residents are not in the labor force.

• Approximately 43% of Franklin County households do not earn enough income to afford necessities and are considered asset limited, income constrained, employed (ALICE) households (United Way of New York State, 2020). The rate of food insecurity in Franklin County is greater than the state average (14% FC vs. 11% NYS; CHR, 2022).

When community members with mental health conditions and/or intellectual/developmental disabilities become involved with the justice system, a 730 examination is required to assess their capability to understand the charges against them and to assist in their own defense. • There were 14 adult 730 cases in 2022, compared with 6 cases in 2021. Thus far in 2023 (January through June), there have been 11 adult 730 cases.

No Need description (Optional): • Behavioral health providers and hospital providers described a trend in the county: Community members with mental health conditions, substance use conditions, and developmental disabilities frequently present in local emergency departments, with some staying for an extended period. Those in need of 9.39 admissions are experiencing substantial wait times for placement.

• Franklin County providers reported significant barriers to securing inpatient services for individuals with complex needs—particularly regarding individuals with IDD diagnoses who are exhibiting aggressive behavior. Providers report a lack of inpatient referral options to meet the needs of these community members

• The most recent data available indicates that, of the 752 Franklin County residents receiving OPWDD services through Medicaid, 360 were dually diagnosed (NYS OPWDD, 2020, retrieved from the PSYCKES portal). Per Franklin County providers, it is particularly challenging to secure 939 placements for individuals who have both IDDs and co-occurring disorders.

No Need description (Optional): • According to providers, Franklin County is experiencing a high demand for 820 services, which are focused on stabilization and reintegration.

• Franklin County continues to receive SPOA referrals for youth in need of residential treatment facilities. In 2022, there were 5 referrals for youth residential treatment facilities, and there have been 5 referrals thus far in 2023 (January through June).

• SPOA referrals for adult residential treatment totaled 121 (41 community resident referrals; 22 apartment treatment referrals; 58 supportive housing referrals). Thus far in 2023 (January through June), there have been 59 residential referrals (19 community resident referrals, 11 apartment treatment

referrals, and 29 supportive housing referrals).

No Need description (Optional): • Franklin County providers report high demand for 589 crisis services for both youth and adults.

• Providers from Citizen Advocates, which offers crisis respite services through the Crisis and Recovery Center, report that beds are typically full and thus are not always available to community members when they require the service.

• Franklin County providers articulated a need for peer-run respite services for adults with mental health needs.

• To date, OPWDD has not developed a rate that supports crisis respite services, which creates barriers to crisis services for individuals with IDD diagnoses.

• Franklin County providers also report a need to expand crisis respite options for children and youth. Hospital providers from Alice Hyde, for example, report that parents are bringing children to the emergency department due to a lack of respite services.

Do any of the Goals on the Goals and Objectives Form address this need? No Need description (Optional): • Franklin County providers are reporting an increase in both housing and service needs among transition-aged youth (those between ages 16 and 24).

• A 2022 survey on housing and service needs of transition-aged youth was completed by 69 providers in the county. Approximately half of the respondents described mental health and addiction services as insufficient for transition-aged youth, while approximately three-quarters of the respondents indicated that housing and support services are insufficient.

• Providers report that transition-aged youth with intellectual/developmental disabilities who age out of school need higher-level community supports. However, IRAs in the county lack adequate staffing to house and support these individuals, resulting in extended wait times.

Need description (Optional): • Franklin County is a rural county located in the Adirondack Park. Its three largest population centers, Malone, Saranac Lake, and Tupper Lake, are separated by large tracts of publicly protected land. The size of the county, distance between population centers, and harsh winters contribute to access barriers to behavioral health services and supports, and to geographic isolation (Adirondack Community Health, 2019).

• According to Franklin County providers, transportation is one of the most significant barriers to service provision, particularly for individuals residing in the south end of the county. Transportation was one of the most frequently cited barriers to services in a recent survey of individuals using mental health services in Franklin County, thus requiring a need for providers to offer mobile services and to conduct more extensive outreach to those in the most geographically remote areas.
