Annual and intermediate plans for <u>developmental disability</u> services:

We will continue to support Mozaic services and residential care as well as Catholic Charities to provide housing and community programs and support. We will work together to improve access to crisis care.

Support for vocational, occupational, social, educational and recreational growth and development will be promoted in the community.

Annual and intermediate plans for mental health services:

We will continue to support the Systems of Care grant iNSYGHT's efforts to better integrate and coordinate services. A focused on improving access to services, family

knowledge of services, support for families and individuals receiving services. Major attention on institutional coordination and cooperation will also occur.

Further work around crisis Intervention Efforts and the diversion of individuals to treatment and support rather than the criminal justice system. Coordination of crisis intervention and Law Enforcement activities and local behavioral health and support services will continue to be a priority.

Prevention services for all ages and in a variety of settings will be supported and expanded.

Residential, vocational, educational and social opportunities will be sought and supported.
